

“2009 AAA Baseball” Sweepstakes Official Rules

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. “2009 AAA Baseball” Sweepstakes begins at 12:00:01 a.m., Eastern Daylight Time (“EDT”) on May 16, 2009 and ends at 11:59:59 p.m., (“EDT”) on August 2, 2009 (“Sweepstakes Period”). Wolff Stadium, San Antonio, TX (San Antonio Missions); Franklin Covey Field, Salt Lake City, UT (Salt Lake Bees); Harbor Park, Norfolk, VA (Norfolk Tides); Cheney Stadium, Tacoma, WA (Tacoma Rainiers); Fox Cities Stadium, Appleton, WI (Wisconsin Timber Rattlers). Place the completed entry form in the designated box at the aforementioned ballpark “Take Me Fishing” kiosks, or will call window. Limit one entry per person or per address. **All entries must be received by the promotion end-date of August 2, 2009.** Incomplete entries or those containing incorrect information will be voided. By participating in this Sweepstakes, entrants agree to be bound by these Official Rules and the decisions of the Sweepstakes Administrator. All entries become the property of the Sponsor and will not be acknowledged or returned.

Prizes: One (1) Grand Prize and one hundred thirty two (132) First Prizes will be awarded. The **Grand Prize Winner** will receive a 3 day/2 night trip for four (4) to Orlando, Florida (the “Trip”). The Grand Prize trip will feature 2 days of 2-hour guided bass fishing excursion (with up to 3 friends aboard a 21-foot Tracker pontoon boat) on the lakes of a Walt Disney World Resort (the “Event); the excursion includes: An experienced guide, Rod and reel, Tackle, Artificial and live bait, and Beverages (Guests may not bring beverages, food or coolers aboard). The trip includes: [1] lodging accommodations for four (4) people for two (2) nights at a Walt Disney World Resort (hotel tax included); [2] round-trip air transportation for four (4) people between the major metropolitan airport nearest to winner's residence (“airport of origin”) and an airport in or near Orlando, Florida; and [3] four (4) one-day passes to Walt Disney World. The Approximate Retail Value of the trip package is \$3,000. The date for the fishing trip will be determined by each individual minor league team; no alternative dates will be offered. The Approximate Retail Value of each local fishing trip is \$250.

Each of the winners must execute liability/publicity and travel companion releases prior to issuance of travel documents.
