



RBFF PHOTO LIBRARY TERMS OF USE

Use of the RBFF Photo Library is governed by the User Agreement for the RBFF websites <http://www.takemefishing.org> and <http://vamosapescar.org> and by these Terms of Use. Please read these Terms of Use carefully as they include important information about your obligations and your permission to use the materials in the Photo Library.

If you do not agree to accept both the User Agreement and these Terms of Use, you may not proceed to download any materials from the Photo Library or use those images in any way. Together, the User Agreement and these Terms of Use constitute an Agreement between you, and if you are accessing these materials on behalf of an organization, between you and the organization (“You” or “User”) and RBFF. By accepting this Agreement, you warrant that you are 18 years of age or older and, if relevant, that you have the authority to accept this Agreement on behalf of the organization.

1. When you accept these Terms of Use and download Materials from the RBFF Photo Library, RBFF grants you a limited, non-transferable, non-exclusive license to access, view, download, and use those Materials as specified herein. Allowing you to download these Materials does not transfer any title from these Materials to you, or any intellectual property rights therein to you.
2. You may under no circumstances redistribute or sell the Materials at any time, or duplicate, download, or distribute any Materials except in accordance with these Terms of Use or as explicitly permitted in writing by RBFF.
3. The Materials may be used only for the purposes and in the media stated in the Registration Statement completed in order to access the Materials, or for an additional purpose or different media stated in any update of that information that you provide to RBFF.
