Barriers & Opportunities to R3

• Barriers:

- TPWD has email addresses for only 13% of licensees
- Complex regulations
 - Difficult to understand
 - Paper tag system
 - Confusing/conflicting language
- Opportunities:



- Simplification of licensing, regulations and processes
- Incorporate overarching marketing / outreach strategies
- Engage diverse committed R3 partner community
- Expand recreational shooting facilities

TPWD Progress to Date

- 2016 Oct: Hunt/Shoot workshop;
- 2017 Feb: Formed internal R3 Planning Team; monthly meetings thereafter
- 2017 Aug: Programs mapped using ORAM
- 2017 Nov: Programs analyzed using RBFF template
- 2017 Dec: R3 writing team appointed
